# Drinking Driver – Million Dollar Settlement

Attorney Steve Spencer recently obtained a one million dollar settlement in a head-on collision. Our client sustained serious multiple injuries when the driver of a commercial vehicle crossed over into her lane, striking her head-on. Investigation determined that the driver had been drinking and working long hours which caused him to fall asleep behind the wheel. The insurance adjuster for the responsible driver initially alleged that our client was at fault because her make-up was found strewn about the car after the accident. U.S. statistics identify head-on collisions as the most fatal type of road accident and they can happen to anyone at any time. While head-on collisions make up only two percent of all accidents, they account for ten percent

of U.S. fatalities. Even when a head-on collision does not claim the life of a victim, the results can be life-changing. Most fatalities could have been prevented if the victim had been wearing a seatbelt. We can't emphasize enough the importance of wearing a seatbelt at all times while driving.
